1. **Discussion on Barrel Rake.** Rule book strongly suggests to rake at 8. Judges and Arena Director set the rake based on ground. Rake goes consecutively through Open Barrels, Jr Barrels and Novice. There is no rake between sections.

5. **Barrel Rake:** Reese mentioned that he was asked at this year's finals as to what type of equipment could be used to rake the pattern. Currently there is no rule that indicates to use a tractor versus 4-wheeler. Discussion was that we cannot make this a rule it has to be left to the committee to utilize what equipment they have available.
